MOVIECHAINER helps entertainment professionals centralize projects and data, carry out their projects and business, report and capitalize on transparent and reliable information. In other words, it's everything entertainment professionals need to optimize their time and revenues, while generating relevant insights on their business performance.

After 7 years accompanying entertainment clients in their daily rights and business management, BACKUP SYSTEMS is proud to its revamped leading product together with a new offer providing more services, enhanced tool customization and frictionless onboarding. Release is set for April 2022.

OUR STORY

As filmmakers ourselves, our aim has always been to find the best tools to improve efficiency and information flow. A few years back, when we needed it, none of the available services felt suitable for our development, production, financing, and distribution business operations (450+ films and series at Backup Media, worth €1b+ production budgets). We had to develop it - MovieChainer.

After a couple of years of development, we introduced MovieChainer to a few partners who naturally became our first clients. By 2020, our client roster included 30+ companies, including powerhouses such as TF1, Memento, The Match Factory, Bron, MK2, Charades, and Fintage House, for which Backup Systems provides tailor-made solutions.

The same year, 2020, with the pandemic disrupting our industry work habits, we decided to strengthen our offer, serve more of our clients needs and help them fully digitize their businesses.

Building upon five years of experience, 2021 marked the year when we were ready to scale our services, transitioning into a unique, all-in-one solution that encapsulates our best innovations. This new approach allowed for quicker, frictionless onboarding and gave our clients the freedom to choose from 100+ features to adapt the service to their trade and needs. Concurrently we embarked on "Connect", an ambitious R&D program, prioritizing innovation and solidifying MovieChainer's robustness and market relevance. Our R&D department focused on machine-learning to enable native interoperability with third-party digital services. Connect was powered by the 7th Innovation "Innov" Award by the French Public Investment Bank, BPI France and our research partner Laboratory of Computer Science and Automatic Control for Systems, a division of the Poitiers University.

Fast forward to 2023, our dedicated team and rigorous development process have brought us to a thrilling turning point. The first milestone of Connect, a revolutionary tool facilitating seamless extraction and integration of raw legal and/or financial data , was introduced at the Cannes film market, ahead of a Q4 23 commercial launch.

The introduction of Connect means much more than a mere addition to our services; We are proud as it highlights our commitment to ongoing innovation, our sense of adaptation, and our dedication to bringing useful tech to the entertainment industry with avant-garde solutions.
